ATTENDANCE POLICY

I understand that my child's attendance at school is critical for his/her education. And it is my responsibility as the parent/guardian to have my child at school and on time. A student must be in the classroom 80% of the time to receive credit for that class. Only emergency absences, approved by the principal, shall not count against the attendance limit. The student is allowed **10** absences per semester, more than this will result in grade being lowered. On the **13th** absence of a semester, the student will receive **NO CREDIT** for that particular hour.

Student Information Forms

DOUBLE CHECK THE FOLLOWING:

- 1. Physical Address- Must be on enrollment form. Must be in our school district. May have to check the school district map located in storage room.**
- 2. Both Guardians cell phone #'s.- must be able to reach either guardian at any time.**
- 3. Language other than English spoken in the home- Language survey must be filled out if answer is Yes.**
- 4. Bus Transportation- If student lives 1.5 or more miles from school, be sure they are put down on the transportation code as such, even though they may not ride the bus, they still are eligible to do so.**
- 5. Auto Transportation- Need to have the student's license # and the make of vehicle they will be driving, and tag #.**

Transportation Codes:

- #0- Does not ride bus as they live in an area where bus does not transport. (Just a few areas in town).**
- #1- Transferred- student is a transfer and does not qualify for transportation.**
- #2- Transferred transported- a possible transfer student with an IEP. (None or very few students).**
- #3- Transported more than 1.5 miles- any student that lives 1.5 miles and is eligible to ride a bus needs to be marked #3. (This code is where the school receives transportation \$\$).**
- #4- Transported less than 1.5 miles- students in town that receive courtesy transportation.**
